

## **2010 Vin It & Win It Cruisin' Camaro Sweepstakes Official Rules**

### **Overview:**

- 1) Starting May 24, 2010 and ending Friday, July 30, 2010, Cavanaugh Auto Group, Sonic-America's Drive In and the Jonesboro Radio Group (Saga Communications of Arkansas, LLC) will give people a chance to win our grand prize.

Grand Prize -- 2010 Camaro LT Coupe; Sales Tax Paid; Full Tank of Gas; Declared Value \$31,850

### **Methodology/Qualifying Prizes:**

People can qualify to win the prize in the following ways:

- 1) Be the designated caller when requested to call on one of the Jonesboro Radio Group Radio Stations (KDXY-FM, KDXY-HD2, KDXY-HD3, KEGI-FM or KJBX-FM). Being the designated caller entitles the caller to a "Vin Number" which is actually qualification for the contest event.

2) Sign up at a Sonic location or at Cavanaugh Chevrolet when Jonesboro Radio Group is doing a Live remote broadcast. Listen to any Jonesboro Radio Group Station (KDXY-FM, KDXY-HD2, KDXY-HD3, KEGI-FM or KJBX-FM) to find out which Sonic location we will be live. You can also call us to find out at 870-933-8800.

To be eligible, the designated caller must be 18 years of age and be able to present a Valid Photo ID at the giveaway event on Saturday, July 31, 2010. There are no exceptions to this rule, even if an on-air disc jockey fails to recognize an underage birthday during the contest and handles the caller as if they are legal age, or if a Jonesboro Radio Group staff member fails to determine at a live broadcast that a person is not the legal age and inadvertently qualifies them for the contest.

A maximum of one free Vin Number per person.

Each person who receives a Vin Number must attend the giveaway event Saturday, July 31, 2010 in order to be eligible to win.

KDXY, KEGI, KJBX, Jonesboro Radio Group, Saga Communications of Arkansas, LLC, its parent corporation, Saga Communications, Inc, their advertising agencies, affiliates, Cavanaugh Auto Group, Sonic, its employees and immediate families, and principals and employees of all media of mass communication within a one hundred mile radius of the Jonesboro Radio Group main studio are not eligible to participate in this contest. Immediate family includes the spouse, great-grandparents, grandparents, parents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This also includes individuals for whom the employee is current legal guardian.

### **Grand Prize Event:**

The Grand Prize giveaway event will take place at Cavanaugh Chevrolet Buick GMC Highway 67 in Walnut Ridge, AR beginning at 11am on Saturday, July 31, 2010. Registration will start at 9am, the winner will be announced at 11am.

When arriving to the event, qualifiers will be asked to present a valid ID to match against the official qualifier list containing all names of those who have qualified. When the match is made, the qualifier will be given their Vin number. The number will be torn at the perforated edge and the qualifier will be given half, the other half will go into the Vin it and Win it Box. Only one Vin Number will be allowed for each qualifier. Even if they qualified more than once on-air or at a Sonic or Cavanaugh location.

Beginning at 11am, staff from The Jonesboro Radio Group will pick someone to draw the numbers out of the designated Box.

### **Grand Prize and Alternate Prize:**

First Number Drawn will be the winner of the Grand Prize

Thereafter, Jonesboro Radio Group staff may draw numbers for additional giveaways like T-Shirts, Caps, and some additional cash.

### **Legal/Restrictions:**

- 1) All qualifiers must be 18 years of age, a permanent resident of the state of Arkansas or Missouri and possess and be ready to produce a valid drivers license.
- 2) All Jonesboro Radio Group General Contest Rules (attached) apply, and all decisions of Jonesboro Radio Group are final.

### **Jonesboro Radio Group GENERAL CONTEST RULES**

Wherever the words Jonesboro Radio Group, KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM appear in these rules, they include the business entity to which the station is licensed, and any member companies, parent corporations, and affiliates. Jonesboro Radio Group means Saga Communications of Arkansas, LLC which owns KDXY-FM, KDXY-HD2, K298AV, KEGI-FM and KJBX-FM, and its sole member, Saga Communications, Inc..

- 1) No purchase is necessary to enter any KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM contest.
- 2) All contestants must be permanent residents of Arkansas or Missouri and must provide KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM with a valid form of identification and Social Security number satisfactory to KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM management.
- 3) Subject to rule (4) below, all contestants must be at least 18 years old to be eligible to participate in contests that include hotel/motel accommodations, motor vehicles, boats, and/or air travel as prizes.
- 4) All contestants must be at least 21 years old to be eligible for all contests affiliated with an alcoholic beverage manufacturer or distributor.
- 5) One entry per household will be permitted to participate in a contest. A "household" is defined as any individuals residing at the same address. - 6) Anytime the KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM on-air studio is called, it is assumed by the caller that the phone call is being recorded and may be broadcast. The caller grants permission to KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM to broadcast the call or record the call for later broadcast.
- 6a) For telephone contests, listeners may enter by calling (870) 930-9105 for KDXY, (870) 935-2468 for KDXY-HD2 and K298AV, (870) 935-1005 for KEGI, or (870) 268-1067 for KJBX. If any problems are discovered by KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM, different call-in numbers or addresses may be substituted and utilized after those numbers and addresses are broadcast on KDXY-FM, KDXY-HD2, KEGI-FM, or KJBX-FM. In the event a caller is disconnected during a contest before his/her name and phone number is recorded, then the prize will be awarded to the next caller whose name and phone number are recorded. The person operating the telephone at KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM has the final decision as to who is the winning caller.

All entries become property of KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM and will not be returned. KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM reserves the right to retain any or all contest materials for any reason that KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM deems necessary to the completion of the contest, or reasons relating to publicity and/or advertising. KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM shall have no responsibility for a contestant's failure to win or claim any prize based on difficulties with telephone, facsimile, email, or internet difficulties, or any circumstances in any contest.

8) Any specific rules and/or restrictions pertaining to individual contests (entry dates, a limit on number or words on an entry, etc.) will be disclosed in on-air announcements.

Otherwise, failure to pick up the prizes by the deadline will result in the forfeiture of the prize, which shall remain the property of KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM. 12) Employees of KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM Jonesboro Radio Group, (and its ultimate parent company, Saga Communications, Inc.), their advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a one hundred mile radius of the KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM main studio are not eligible to win any contest. Immediate family includes the spouse, great-grandparents, grandparents, parents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This also includes individuals for whom the employee is current legal guardian.

13) All prizes are non-transferable and are not redeemable for cash. KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM reserves the right to substitute a prize of similar value. KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM cannot be held responsible for unforeseen cancellations or delays of concerts/events or transportation caused by weather, promoter or performer.

14) Winners are solely responsible for all applicable local, state and federal taxes. Winner may be issued a 1099 MISC federal tax form if in one calendar year the prize value of all prizes won in contests from KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM and/or participating co-sponsors exceeds \$600.00.

a) All appropriate information in required fields must be filled out or contestants will be disqualified.

b) To be eligible to win a prize, a contestant must reside within the listening area of KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM, as defined within the exclusive discretion of KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM management.

c) Any problems with the internet or email are not KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM responsibility.

d) Contestants who attempt to register to participate on KDXY-FM, KDXY-HD2, KEGI-FM, or KJBX-FM's websites may be required to produce a printed copy of proof of registration before being allowed to participate in the contest.

17) Due to the nature of our programs that are heard on-line over the internet, contests heard on the radio station's internet audio stream are slightly delayed from the time the contests are heard on the broadcast station, and will be running behind the broadcast signal. Thus, all contests heard are delayed. This delay can last for as much as 30 seconds or more. This means that when Jonesboro Radio Group, KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM contests are played that require a specific caller to telephone the radio station (such as "Caller number 10 when you hear the sound effect"), listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contests on-air."

18) All giveaways and contests are void where prohibited by law. All local, state and federal regulations apply. As a licensee of the FCC and a trustee of the public airwaves, KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM reserves the right to interrupt and/or discontinue any contest or promotion (and not award the offered prize) at the discretion of KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM management if world events, the national mood, or public safety so warrant. KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM reserves the right to disqualify any winner if the contest rules have been violated in any way. KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM reserves the right to amend the rules to any contest at any time. 19) Although KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM will make reasonable efforts to conduct its contests substantially as announced or advertised, KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM reserves the right in extraordinary situations to change or modify the rules of its contests as exigent circumstances may require. In such cases, KDXY-FM, KDXY-HD2, KDXY-HD3, K298AV, K224DW, KEGI-FM, or KJBX-FM will amend the rules for that contest and broadcast the amended rules as promptly as possible. In such case, the contest will be conducted in accordance with the amended rules.
